

**ADDENDUM TO THE ZANESVILLE COMMUNITY HIGH SCHOOL SPONSORSHIP

**Whereas**, the Zanesville City School District and The Zanesville Community High School are parties to a Community School Contract signed 4/17/2012;

**Whereas**, The Zanesville Community High School desires to modify the aforementioned contract to adhere to guidelines set forth by the Ohio Department of Education for Community Schools in 3314.03 *Specifications of contract between sponsor and governing authority - specifications of comprehensive plan*;

**Whereas**, the Zanesville City School District desires to grant this modification to the terms of the Community School Contract;

**Now Therefore**, the parties agree to modify the sponsorship contract accordingly by adopting the following into the comprehensive plan:

- ◊ A requirement that each classroom teacher initially hired by the school on or after July 1, 2013, and employed to provide instruction in physical education hold a valid license issued pursuant to section 3319.22 of the Revised Code for teaching physical education.
- ◊ The governing authority of the school, which shall be responsible for carrying out the provisions of the contract; - Provide updated names, contact information including email, telephone, and address of board members.
- ◊ The following from the Ohio Revised Code:
  - 3302.041** Failure to make adequate progress - corrective actions.
  - 3313.6014** Parental notification of core curriculum requirements.
  - 3313.6015** Resolution describing how district will address college and career readiness and financial literacy.
  - 3313.718** Possession and use of epinephrine autoinjector to treat anaphylaxis.
  - 3313.719** Food allergy protection policy.
  - 3313.814** Standards governing types of foods and beverages sold on school premises.
  - 3313.816** [Effective Until 9/24/2012] Sale of a la carte beverage items.
  - 3319.321** Confidentiality.
  - 3319.39** Criminal records check.
  - 3319.391** Applicants and new hires subject to criminal records check provisions.
  - 3321.041** Excused absences for certain extracurricular activities.

**Whereas**, the Zanesville City School District and The Zanesville Community High School are parties to a Community School Contract signed 4/17/2012;




**Whereas**, the Zanesville City School District desires to grant this modification to the terms of the Community School Contract;






