"To Date" Financials Mike Hall

- To-date comparison to FY21
- Enrollment, Revenue, and Expenses have all increased from FY21
 - 8.7%, 28.4%, and 30.6%, respectively
- Cash balance has increased from FY21
 - Increased 5.6%
- Title funding and De La Salle support will be reflected at the end of the month, meaning that revenue will likely outpace expenses

Executive Director Update

2021 - 2022 Summer School Update LaShanda Boone, Lauren Cobb

- Summer school enrollment: 45 students
- Programming
 - African American timeline and writing
 - 6th and 7th grade math (reinforcing math skills)
 - Active physical education
 - Male empowerment and leadership
- Summer school ends June 30

2022 - 2023 SEL Program Update LaShanda Boone, Lauren Cobb

- Provided by Care and Counseling
 - o In response to SQR and CSIP goals
 - Will be introduced at the beginning of 2022-2023 school year
 - Will assess students at beginning of the school year (around socio-emotional development) in effort to provide targeted resources to students and families
- School counselor will be primary liaison between students and families

Research-Practice Collaborative with SLU LaShanda Boone

- Opportunity shared by Robbyn Wahby
- Currently working with two largest charter schools in St. Louis
- Essentially a data sharing agreement among charter schools
- Will provide useful information to potentially improve recruitment and retention efforts
- Approved by Board at 6:24p

2022 - 2023 Enrollment Update LaShanda Boone

- Goal for 2022-2023: 130 students
- Currently ~100 students confirmed for 2022-2023
- Currently at ~89% student retention

Dashboard - Accountability Plan LaShanda Boone

- Attendance has been a challenge shared across districts
- Fighting has been an issue
- 48 of 53 eighth grade students have secured high school placement
 - 48% going to private/independent schools
- Ended the school year with 124 students (resulting in being slightly under budget)

Marci mentioned possibility of Board retreat, with the intention of revisiting and level-setting on some governance procedures. As well as revisiting financial support that was intended with the restructuring.
