MINUTES OF REGULAR MEETING OF THE FINANCE COMMITTEE OF THE BOARD OF DIRECTORS OF EWING MARION KAUFFMAN SCHOOL, INC.

January 29, 2024

A regular meeting of the Finance Committee of the Board of Directors of Ewing Marion Kauffman School, Inc., a Missouri nonprofit corporation exempt from federal taxation under Internal Revenue Code § 501(c)(3), was held at the Ewing Marion Kauffman School in Kansas City, Missouri on January 29, 2024, pursuant to public notice provided at least 24 hours in advance. The meeting was held using audio-video technology with a link provided in the notice and with opportunities for all to hear and be heard and see and be seen.

Participating were Kristin Bechard, Treasurer; Jerry Williams, Board Chair; and Vickie Harris.

Also participating from the School were John Tyler, Secretary and General Counsel; Katie Pasniewski, Chief Operating Officer; Matt Overbaugh, Director of Finance; and Jamie Berry from EdOps, the School's contracted accounting firm.

No community members were present.

Ms. Bechard chaired the meeting and Mr. Tyler served as secretary. Ms. Bechard called the meeting to order at 5:31 pm., welcomed those in attendance, and previewed the agenda.

After discussion and upon motion duly made (Williams) and seconded (Harris), the Committee unanimously approved the minutes from its meeting of January 8, 2024.

Treasurer's Report

Mr. Overbaugh presented the Treasurer's report, including an overview of his presentation, that W2s and 1099s have been distributed, a revised forecast projected to reduce cash holdings by about \$800,000 along with then also reducing projected days of cash (from 219 to 196), the ability to use the prior year's WADA which helps income and its flow, explanation of revenue changes (interest income and transportation funding), offsets by lower Prop C and Title funds, and expense changes in the forecast with an increase of \$900,000 and the reasons for the changes (salary and benefits, transportation, occupancy services (security and janitorial), and student expenses (food due to inflation and timing for tech expenses)).

He also reported that planning for FY2025 has begun and will be presented to the committee in April with a full board vote expected in May.

Discussion followed, including about transportation costs and how shared routing with University Academy results in savings of about 25% and not being as affected by the shortage of bus drivers.

Mr. Overbaugh highlighted the status of key performance indicators for the statuses of days of cash, staffing, and enrollment which either exceed objectives or are close to them.

He provided an overview of the forecast, including an increase in revenue of \$590,000, a decrease in expenses of \$239,000, a change in net income at an increase of \$352,000, and change in cash at the same amount.

After discussion and upon motion duly made (Harris) and seconded (Williams), the committee voted unanimously to recommend that the board approve the Treasurer's report, including the check register, as presented.

Other Items

Ms. Bechard explained the proposed change to the signature card at Commerce Bank to add Mr. Overbaugh as a signatory to the operating account and the rationale for doing so such that only the following are authorized signatories to the account: Hannah Lofthus, President/CEO; Katie Pasniewski, COO; Mat Overbaugh, Director of Finance; Jerry Williams, Board Chair; Kristin Bechard, Treasurer; and John Tyler, Secretary.

After discussion and upon motion duly made (Williams) and seconded (Harris), the Committee unanimously approved recommending that the board authorize Mr. Overbaugh as a signatory on the operating account and further approves all standard bank resolutions necessary and appropriate for doing so.

There was no community forum because no community members were present.

Ms. Pasniewski explained that auditors will not need to be engaged by February but can be engaged later. Mr. Overbaugh listed the firms to which RFPs have been sent to provide external financial audit services. Discussion also occurred about the reviewer role traditionally fulfilled by Westbrook.

Ms. Pasniewski highlighted the status of financial services and operations since Mr. Overbaugh joined the staff and how role clarity and responsibilities might evolve over time. Discussion occurred throughout.

There being no further business, the meeting adjourned at 6:15 pm.

- As of 2/29/24, EMKS has a year end cash projection of \$11M. This has not materially changed from the 12/23 forecast. Days of Cash for year end is 195 Days. Forecasted net income is favorable to budget \$0.3M
 - Including restricted cash, the total YE forecast cash balance is \$16,746,548
 - \$100,000 restricted for Board PD
 - \$2,947,669 restricted for facilities
 - \$2,000,000 restricted for strategic planning
- Revenue
 - As noted in prior months, we are using FWADA from FY22 which increases the school's basic formula revenue. If we were using the current enrollment/WADA, revenue would be reduced by \$2M



Revenue

- FY forecast is now \$23.5M or +\$0.1M vs. last forecast. Compared to budget, revenue is +\$0.6M or 2.5% favorable driven by WADA calc., transportation income and interest income
- Expenses
 - Compared to budget, expenses are now \$0.4M above budget. Primary drivers of the increase were staff benefits +\$0.2M, occupancy services +\$0.3M, and student expenses +\$0.5M, partially offset by savings in transportation -\$0.3M and staff salaries -\$0.8M



Current vs. Budgeted Staffing




Cash Forecast

EMKS is projected to spend ~\$150k on Athletics Transportation this year

- The driver of spend is transportation to practices off campus and athletic events through bus/van charter services primarily provided by vendor KC Knight Train
 - Historically we have used our school transportation services (Apple/First Student) to provide activities transportation, however, the bus driver shortage has removed this as an option
- Often multiple vans/busses are needed on the same day to get student athletes to multiple locations
- Having four EMKS 8 passenger minivans would reduce the usage of third-party services by 50%+. Anticipated annual savings of \$75k+ a year
- We have checked with current State of Missouri rules for school transportation and any 10 person or smaller vehicle doesn't require additional safety features like a bus
- Insurance costs are comparable to personal insurance on a regular automobile
- No additional licensing is required to drive a school minivan
- Buying normal passenger minivans allows us to easily pivot (resale) if we find the solution does not best meet our needs as expected vs. larger vans or busses
