As of 6/19/2024, the Enrollment Dashboard showed:

- Current Enrollment: 965
- New Registrations in Progress: 174

- Students, end of the year: 913 (5% attrition, in line with 2023-2024)
- Attendance: 85% (Up slightly from 83.5% for 2023-2024)

Notable Changes

- State Funding Increase of \$2.6 million due to full enrollment of high school and increase in state funding.
- Federal Revenue Decrease of \$2.3 million due to the end of ESSER III funding
- Student Expense, Direct \$250k decrease, some due to one time expenses related to ESSER III and some tightening of spending policies.
- Transportation \$476k increase which relates to a projected 25% increase over prior year.
- Not included in this budget is an additional \$144k that will be included in the Office and Business Expense line to access needs for the school and to implement our new Executive Director's vision for the future.

- 59% of KIPPsters from the Class of 2025 who applied for KC Scholars' Traditional scholarship earned \$50,000 each—totaling \$800,000 in scholarships!
