

**SECOND AMENDMENT
TO RENEWAL COMMUNITY SCHOOL SPONSORSHIP CONTRACT
FOR
GOAL DIGITAL ACADEMY
IRN #149047**

WHEREAS, the Governing Board of Mid-Ohio Educational Service Center (the “Sponsor”) and the Governing Authority of GOAL Digital Academy (the “Board of Directors” or “School”) (collectively, the “Parties”) are parties to a Renewal Community School Sponsorship Contract for GOAL Digital Academy, IRN #149047 with a term expiring on June 30, 2025 (the “Contract”).

WHEREAS, the Parties desire to amend the Contract due to changes in law.

NOW THEREFORE, the Board of Directors and the Sponsor enter into this Second Amendment to the Renewal Community School Sponsorship Contract with the following terms and conditions:

1. Article IV, Section F.

- a. In the first sentence of the section insert as a new explanatory clause “, unless the SCHOOL is an internet- or computer-based community school that does not qualify for a dropout prevention and recovery report card, in which case the SCHOOL must comply with 3314.261” after “3321.191 [attendance, habitual absence, truancy].”
- b. In the first sentence of the section insert the following new statutory citations in appropriate numerical order:
 - i. 3302.037 [report cards]
 - ii. 3313.6026 [FAFSA data sharing]
 - iii. 3313.669 [threat assessment teams]
 - iv. 3313.6610 [anonymous threat tip line]
 - v. 3319.077, 3319.078 [multi-sensory structured literacy certification]
 - vi. 3319.238 [financial literacy license validation]
 - vii. 3319.318 [assisting sex offender in attaining employment]
 - viii. 3319.393 [educator profile database consultation]
 - ix. 3320.01, 3320.02, 3320.03 [religious expression]
 - x. 3323.251 [dyslexia screenings]
 - xi. 5502.262 [emergency management plan]
- c. Remove from the section the statutory citation to 3313.536 [emergency management plan].

- 2. Article IV, Section I, Subsection i.** In the second sentence insert “the requirements prescribed in R.C. 3313.6027 and” after the phrase “successfully complete.”

3. **Article IV, Section O.** At the end of the first paragraph, insert the following sentence “Notwithstanding anything to the contrary in this section, parents of students who enter ninth grade for the first time in the 2022-2023 school year may elect not to have a nationally standardized assessment administered to that student.”

4. **Article IV.** Insert the following paragraph as a new **Section U**:


In the event that the SCHOOL ceases to qualify as a dropout prevention and recovery school, the SCHOOL shall adopt an attendance policy in accordance with R.C. 3314.261, which shall detail: (1) the classroom-based and nonclassroom-based “instructional activities” that a student is expected to complete, participate in, or attend during the school day; and (2) certain consequences, including disenrollment from the SCHOOL, if a student fails to participate in instructional activities.

5. **Exhibit 4** shall be inserted with the attached.

The Parties agree the terms of this Amendment will be incorporated into the Contract between the Parties. All other terms and conditions of the Contract shall remain in full force and effect. This Amendment represents the entire agreement between the Parties with respect to its subject matter and shall only be amended by a signed writing.
