

SECOND AMENDMENT TO THE AMENDED AND RESTATED CONTRACT

for an OHIO COMMUNITY SCHOOL between the

Bowling Green State University

and Toledo School for the Arts

WHEREAS, Bowling Green State University, a state-assisted institution of higher education established and existing under the laws of Ohio ("BGSU"), and the Governing Authority of a charter school named Toledo School for the Arts (the "School"), an Ohio nonprofit corporation and public community school, have entered into a 2019-2022 contract (the "Contract") for a charter school; and

WHEREAS, laws governing the operation of charter schools have been revised;

NOW, THEREFORE, the School and BGSU agree as follows:

1. In Section 4.1, the first paragraph is deleted and replaced with the following (new text indicated in **bold and underlined**):

"The School shall comply with sections 9.90, 9.91, 109.65, 121.22, 149.43, 2151.357, 2151.421, 2313.19, 3301.0710, 3301.0711, 3301.0712, 3301.0714 (as stated in 3314.17), 3301.0715, 3301.0729, 3301.948, 3313.472, 3313.50, 3313.536, 3313.539, 3313.5310, 3313.608, 3313.609, 3313.6012, 3313.6013, 3313.6014, 3313.6015, 3313.6020, **3313.6024**, 3313.643, 3313.648, 3313.6411, 3313.66, 3313.661, 3313.662, 3313.666, 3313.667, 3313.668, 3313.67, 3313.671, 3313.672, 3313.673, 3313.69, 3313.71, 3313.716, 3313.718, 3313.719, 3313.7112, 3313.721, 3313.80, 3313.801 (unless the School is an internet- or computer-based school), 3313.814, 3313.816, 3313.817, **3313.818**, 3313.86, 3313.89, 3313.96, 3319.073, 3319.074, 3319.075, 3319.321, 3319.39, 3319.391, 3319.41, 3319.46, **3320.01**, **3320.02**, **3320.03**, 3321.01, 3321.041, 3321.13, 3321.14, 3321.141, 3321.17, 3321.18, 3321.19, 3321.191, 3327.10, 4111.17, 4113.52 and 5705.391, Chapters 117., 1347., 1702., 2744., 3314., 3365., 3742., 4112., 4123., 4141., and 4167. of the Ohio Revised Code as if it were a school district. Unless prohibited by the United States Constitution, the Ohio Constitution, or other controlling law, the School will comply with these sections and chapters of the Ohio Revised Code now in effect and as hereafter amended. Certain laws listed above which are not specified therein as mandatory are permissive, unless otherwise specifically required under this Contract. Laws listed above which are mandatory are also mandatory under this Contract."

2. In section 4.1, the fifth paragraph is paragraph is deleted and replaced with the following (new text indicated in **bold and underlined**):

"The School shall comply with R.C. 3313.61, 3313.611, 3313.614, **3313.617**, **3313.618**, and **3313.6114**, as qualified by R.C. 3314.03(A)(11)(f) and outlined in section 6.11 below."

3. Pursuant to House Bill 164 as passed by the 133rd General Assembly, for the 2020-2021 school year, the School's remote learning plan, as attached and as may be amended by the governing authority, shall be incorporated into the education plan, attachment 6.3.


4. All other provisions of the Contract remain unchanged.
