> Currently, our school is going through the process of completing the transfer from MU to the State of Missouri Charter Commission. This process has been long and can at times seem cumbersome. I have asked those in the charter commission office to make me

their **only** contact person and I will get you the needed information that comes from them. There have apparently been issues with some from the charter office reaching out directly to BOE members and other school personnel without my knowledge. Moving forward, any information that needs to be shared from the charter commission will come directly from me.

- 2. COVID Update There have been no cases or exposures due to COVID in our school since our last meeting. We believe that this is a direct outcome of continuing masks in our building and we would like to continue this practice until the end of the year
- 3. We did have an outbreak of the stomach flu and virus. Many students and some staff were affected. Thankfully, that has died down and we are back to a sense of normalcy.
- 4. We have started the process of working with each department on potential budget needs for next year. As we are beginning this process, we have a goal in mind to reduce expenditures over last year and we do have a plan in place for that.
- 5. Our data from MAP this year will be used as baseline data as we build our school improvement strategic plan. Once the MAP test is complete we will begin building our strategic plan of improvement. Our initial goal to reduce the number of students scoring in below basic appears to be a goal that is met. We don't have the exact numbers but as soon as we get them I will update the BOE. I am basing this on the Evaluate test, which can be used as a predictor of student scoring on MAP.
- 6. Our Instructional Leadership Team will be convening on March 16-17 at Kauffman to begin the work of our school strategic plan for the next 4 years. The plan will include academic targets, behavioral targets, and more.
- LINC may be in the process of cutting funding to schools in the area. Bishop Tolbert will
  reach out to the Boys and Girls Club of KC as possible before and after school care for
  K-8.
