

**MOMENTUM ACADEMY
FINANCE COMMITTEE REPORT**

MAY 2024

The Momentum Academy Finance Committee (FC) met on May 13, 2024. The main topics of discussion consisted of the financial reports for the fiscal year through April 2024 and the second draft of the budget.

Financial Reports

- The financial statements included an income statement, balance sheet, monthly projections, and key performance indicators (KPIs). All KPIs (days of cash at year end, gross margin margin, and fund balance at year end) exceeded targets.
- As of April 30, 2024, there was approximately \$3.7 million in cash, with current available cash of approximately \$2.6 million due to letters of credit and approximately \$3.8 million in cash forecasted for fiscal year end.
- Total revenue is up approximately \$814k for the fiscal year to date compared to budget.
- Revenue increased by \$19k over last month's financials, primarily due to a private grants and bank interest, but expenses increased by \$155k from last month's financials.
- Net income for April was \$57k, and the forecasted annual net income is approximately \$191k.

Budget

- Reviewed second draft of the budget, with a focus on the budget for FY '24-'25 but also looking at forecasted for the next few fiscal years after that.
- Plan to present budget for FY '24-'25 to the Board for approval at the May Board meeting.

Other topics of discussion included the following:

- The April check register, which reflected approximately \$665k in expenses.
- Goals for maintaining current enrollment levels, achieving enrollment levels for next school year, and working on recommitment efforts.
- Attendance targets and actuals, including meeting and exceeding the 90% budgeted attendance and targeted efforts to move closer to the 92% attendance goal.
- Contracts, offer acceptances, and retention levels for current staff, and current staffing and vacancies.
- The Audit RFP and responses from potential auditors.
- Updates on status of insurance and benefits proposals.

- Report on the internal control over financial reporting and compliance with provisions of laws, regulations, contracts, and award agreements, noncompliance with which could have a material effect on the financial statements in accordance with *Government Auditing Standards*.
- Report any findings to management and present the audit reports to the Board of Directors.
- Prepare and file the IRS Form 990 and any other required state and local tax forms.

Audit Approach

The Audit Process is divided into five segments:

1. Planning: June/July

We will review prior year audit working papers, prior year reports, significant contracts, and conduct interviews with the Board and other personnel. During this phase, we obtain an understanding as to the design of internal controls and provide a detailed list of audit requests to include examples and templates. A pre-fieldwork meeting can be held with the Board and management to discuss any additional audit requirements or risks.

2. Field Work: September/October

Field work will be scheduled at your convenience and conducted at your location. We will perform testing on the accuracy of the financial statements as it relates to our sample. We will utilize analytical procedures to identify areas with fluctuations that exceed our expectations based on historical performance, board approved budgets and industry standards. Our procedures will substantiate the numbers in the financial statements and test the appropriateness of the significant accounting policies disclosed in the notes to the financial statements.

3. Report Preparation and Review

At the completion of the fieldwork, we will draft the financial statements and related footnotes. We will ensure the most recent accounting principles are being applied and that the footnotes are complete and accurate. We will provide a draft for management's review and approval.

4. Final Report Issuance: November

After management has approved the draft of the report, we will have a meeting with the Board to discuss the report. We will provide the Board with a letter summarizing the audit process and disclosing any findings or recommendations that we have. After the Board has approved all deliverables, we will ask management to provide us with a signed representation letter prepared by our team that summarizes the significant representations made during the audit. The report will be finalized and delivered no later than November 30th each year.

The tax return preparation will be done throughout the audit process and completion of the return will be done after the audit report is approved for final delivery. We will provide a draft for management's review and for board distribution and approval. Once we receive the signed 8879 form, the return will be e-filed with IRS prior to its deadline.

5. Post-Audit Support: Year-round

We are available throughout the year to assist management with any unusual or complicated accounting issues should they arise. If we determine a policy or regulatory change will have a significant impact on the Academy, we will perform all necessary research and meet with management to discuss all appropriate options.

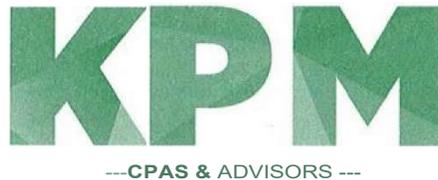

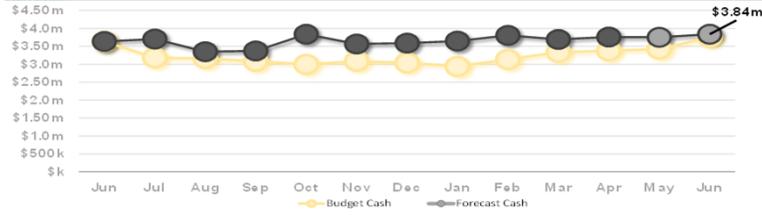
