- Building and Site Improvements:
  - Parking Lot Update: Construction to begin immediately. Zoning and all contractors have been updated. Trees will be cleared, retaining walls to be built. Mr. Leone to be a point of contact for business and communications. Hopeful for December finish.
  - O Bond Update: A general obligation bond ("GO Bond") is a type of bond that allows state and local governments, including school districts, to raise money for projects that may not directly generate a revenue stream. GO Bonds are not backed by a revenue producing project or asset. Rather, GO Bonds are backed by the "full faith and credit" of the issuer. This means that GO Bonds are backed by the issuer's ability to tax, and to raise taxes, if necessary, in order to pay bondholders. For school districts, this usually means the ability to increase property taxes. KCPS has stated the plan is for the GO bond to be on the April 2025 ballot.
- KCIA Public Relations Discussion (Dr. Stacy King): WECreating and maintaining a positive public image for KCIA with an updated and appealing website. Adding design and features that are user friendly and attractive for interaction
  - Website Update: Currently 7 yrs old
  - Video Update: Want to add 30 second commercials

- Spanish Translator (Dr. Stacy King) the need for translation support is greatest, based on current enrollment.
  - Consistent Content Support: Students need consistent support from a translator to access course content.
  - Occasional Social: Students need touchpoints with a translator to problem-solve and understand key information about U.S. schools but support is not needed daily.
  - 22% of students need translator support (137 students)

Motion by Sycil Proffitt to hire a Spanish translator for high needs area and support. Joycelyn Strickland-Egans to second. Motion carried unanimously

- Kansas City Regional Fusion Center MOU (Dr. Stacy King)
  - The Kansas City Regional Fusion Center brings local, state and federal law enforcement officials together with public and private organizations to detect, deter and respond to terrorist threats in the Greater Kansas City community. The Fusion Center's Interagency Analysis Center collects information from a variety of sources. This data is evaluated and analyzed in an effort to identify potential trends or patterns of terrorist or criminal operations within the region.

Motion by Ramsey Atieh to approve the MOU for the Kansas City Regional Fusion Center. Joycelyn Strickland-Egans to second. Motion carried unanimously.
