#### Highlights from the review (See full statements in links above):

- Cash on hand: 154 days.
- Consolidated assets are approximately \$17,676,800 and total liabilities are approximately \$14,969,700 resulting in net assets of \$2,707,100. (These amounts exclude any depreciation of the property and equipment for the 2024 fiscal year.)
- Actual revenue year-to-date is approximately 73% of the Board budget, which is approximately 6% more than budgeted on an annualized basis.
- Actual expenditures are approximately 63%% of the Board budget which is approximately 4% less than budgeted on an annualized basis.
- Ending the month with \$2,336,669.51 in cash.

A bright spot during the meeting was the presentation of the FY23 Annual Report by the Missouri Charter Public School Commission (MCPSC). Shawn Williams, MCPSC's Deputy Director of Community Engagement presented the results via phone. The net from Mr. Williams and the MCPSC is that Atlas-both Colby/staff and Board continue to provide the children at Atlas with high quality learning opportunities.

# **Executive Director Report: 6:15-6:30 pm**

- ADA: 90.56% Current Enrollment: 302

#### Colby updated the Board on three main areas:

- The Average Daily Attendance (ADA) continued to be solid at Over 90% and the current enrollment is 302.
- He reviewed the 2024-25 recruitment dashboard and active applications for kindergarten is strong at 76-ahead of last year's schedule (Goal is a minimum of 104).
- Atlas will be adding 16 new staff members next year, including five new classroom lead teachers.
  Six of those 16 positions have been filled with numerous interviews upcoming in the next couple of weeks.
