

**FIRST AMENDMENT
TO
CONTRACT FOR OHIO START-UP COMMUNITY SCHOOL**

WHEREAS, Richland Academy of the Arts (“RAA” or “Sponsor”) and Dublin Preparatory Academy (dba Northside Preparatory Academy) (“School Governing Authority” or “School”), an Ohio non-profit corporation, entered into a Community School Contract (“Contract”) effective July 1, 2023; and

WHEREAS, pursuant to Article IX of the Contract, from time to time at the Sponsor’s discretion, RAA may require modification of the Contract in order to ensure the School’s compliance with all laws, rules or regulations, and sponsor evaluation procedures;

NOW THEREFORE, RAA and the School Governing Authority agree to the following amendments to the Contract:


- **Article II, Section A, Subsection 1, Division xiv.** Add Sections 3313.5318, 3313.5319, 3313.6028, 3313.6029, 3313.6413, 3313.7117, 3313.819, 3322.20 and 3322.24 in appropriate numerical order.
- **Article II, Section A, Subsection 1, Division xv.** Add Sections 3319.0812 and 3319.324 in appropriate numerical order.
- **Article V.** Add as a new Section G “PROHIBITION OF EMPLOYMENT. The School shall not employ an individual in a position if the State Board of Education has permanently denied the individual an educator’s license or if the individual has entered into a consent agreement with the State Board of Education agreeing to never apply for an educator’s license.
- **Article VIII, Section A, Subsection 3, Division vii.** Insert “, which may include attendance at required training at the discretion of the sponsor” at the end of the sentence.
- Replace with “Ohio Department of Education” with “Ohio Department of Education and Workforce” through entirety of the contract.

ALL OTHER SECTIONS, SUBSECTIONS, PARTS, TERMS OR PROVISIONS OF THE CONTRACT, AND AS HERETOFORE AMENDED, SHALL REMAIN IN FULL FORCE AND EFFECT UNLESS OTHERWISE SPECIFICALLY MODIFIED HEREIN.

IT IS FURTHER RESOLVED that the Board Chair is authorized and directed to execute any and all forms, and/or documents required in connection or by reason of this resolution.


