Month Ending November 30th, 2024 Summary Financials:

Mr. Foster informed the board members of the Evaluate testing results testing ELA and Math trends. He shared the growth by grade level. The December results determined that there is growth in both Math and ELA in grades 3,4,6, and 8 for ELA and 3,4,5,6, and 8 improved for Math.

- 1. Enrollment Update: Kevin gave the board members information about enrollment for the 24-25 school year. The Average Daily Membership is 179 students and we budgeted for 186 students. The Average Daily Attendance is 162 and we budgeted for 167 students. The attendance percentage is 90.1%.
- 2. Staffing Update: Inside the board packet is a list of all new and returning staff members and their certification status. We have added a new kindergarten teacher Ms. Courtney Kretschmar. We've replaced the middle school ELA teacher with Mr. Love, formally the middle school science teacher and moved Mr. Jones to serve as a long term science teaching sub. We are still hiring for a reading interventionist, counselor, and a middle school science teacher.
- **3. Renewal Update:** On January 6th, 2025 Ms. Robbyn Wabby, with the Commission which is our sponsor will let us know if we should continue to be renewed.
