- To-date comparison to FY21
- Enrollment, Revenue, and Expenses have all increased from FY21
  - 8.7%, 29.4%, and 29.2% respectively
- Cash balance has increased from FY21
  - 15.1%
- ESSER III funds are now reflected in financials
- Phil: Questions around legislation for charter school funding
  - Estimated revenue-per-student increase (if legislation passes): \$1,800
- Phil: Questions around staff salary increases of neighboring districts

**Graduate Support Update** *Dr. Jasmine Clay*

- 83% of eighth graders have confirmed high school plans

- About 44% have chosen private or independent high schools
- About 56% have chosen public high schools
- About 86% of current high school seniors have plans after high school
  - Jasmine working closely with students who do not have plans after high school
- Remaining (17%) are on waitlists, planning to relocate, or are otherwise awaiting future movements
