

**ADDENDUM TO SUCCESSOR COMMUNITY  
SCHOOL SPONSORSHIP CONTRACT**

This Addendum to Successor Community School Sponsorship Contract (hereinafter referred to as "Addendum") is entered into on this 29<sup>th</sup> day of November 2018 by and between the Governing Board of the North Central Ohio Educational Service Center (hereinafter referred to as "Sponsor") and the Governing Authority of Eastland Preparatory Academy (hereinafter referred to as "School"), and hereby amends and supplements their Successor Community School Sponsorship Contract in effect from July 1, 2018 to June 30, 2023 (hereinafter referred to as "Contract").

WHEREAS, the Ohio General Assembly has recently enacted new legislation pertaining to community schools; and

WHEREAS, the Sponsor and the School desire to execute this Addendum in order to comply with such legislation and with the directives issued by the Ohio Department of Education.

NOW, THEREFORE, for mutually acceptable consideration, the Sponsor and the School hereby agree as follows:


1. The School may enroll students in grades Kindergarten through Twelve.
2. The School shall adopt an attendance policy that includes a procedure for automatically withdrawing a student if the student without a legitimate excuse fails to participate in seventy-two (72) consecutive hours of the learning opportunities offered to the student.
3. The School shall adopt an enrollment and attendance policy that requires a student's parent to notify the School when there is a change in location of the parent's or student's primary address.
4. Upon the enrollment of each student and on an annual basis, the School shall verify to the Ohio Department of Education the school district in which the student is entitled to attend under R.C. 3313.64 or 3313.65. The School shall also review the residency records of its students on a monthly basis.
5. The School shall adopt a student residence and address verification policy for students enrolling in or attending the School. Said policy shall prescribe the number of documents listed in R.C. 3314.11(E) required to initially verify a student's residency, and shall prescribe the information required to annually verify a student's residency.
6. The School shall comply with R.C. 3319.074 as if it were a school district.

7. In the event that the School permanently closes, the Sponsor shall oversee and provide assistance to the School in complying with the community school closing procedures mandated by the Ohio Department of Education.
8. The aforementioned Contract amendments shall take effect immediately unless otherwise specified herein. All terms and conditions set forth in the Contract, except for those amended pursuant to this Addendum, shall remain in full force and effect.
