Any change in registered agent or registered agent address must be filed immediately with our office. Please be sure to file your report on time; **failure to file this report will result in administrative dissolution of your corporation.**

You may file your Registration Report online 24 hours a day on our website at: www.sos.mo.gov. If online filing is not an option, you may print your Registration Report from our website at www.sos.mo.gov or you may call toll free (866) 223-6535 and request a form be sent to you.
