Dear Superintendent:

This letter informs you of the statutorily required sponsor evaluation ratings and your overall rating for the 2015-2016 school year. The overall rating is based on three equally weighted components: academic performance, adherence to quality practices, and compliance with all applicable laws and rules. A copy of your overall rating is enclosed, and the details of each rating are available to view in Epicenter.

Based on the scores for each component, Southwest Licking Local received an overall rating of **POOR**.

Pursuant to Ohio Revised Code 3314.016(B)(7(c), sponsors receiving ratings of "poor" shall have their sponsorship authority revoked. The revocation will not occur until the appeal process is finished. You may appeal this rating within 30 days after receiving the rating by filing a notice of appeal with the State Board of Education.

Upon receipt of the notice of appeal, the superintendent of public instruction appoints an independent hearing officer to conduct the hearing in accordance with Chapter 119 of the Revised Code. The hearing is conducted within 30 days of the notice of appeal. Within 45 days after the hearing is completed, the State Board of Education shall determine whether the revocation is appropriate based on the hearing conducted by the independent hearing officer, and if determined appropriate, the revocation shall be confirmed. A sample notice of appeal is enclosed.

If you do not timely appeal this finding or the SBOE confirms the revocation of your authority, the Ohio Department of Education's Office of School Sponsorship will assume sponsorship of the schools you sponsor for the remainder of the school year.

If you require more than 30 days to obtain supporting documentation, you may request an extension by fi ling a Request for Extension form with ODE before the expiration of this 30–day deadline.
