

**ADDENDUM TO SUCCESSOR COMMUNITY  
SCHOOL SPONSORSHIP CONTRACT**

This Addendum to Successor Community School Sponsorship Contract (hereinafter referred to as "Addendum") is entered into on this 16<sup>th</sup> day of September, 2021 by and between the Governing Board of the North Central Ohio Educational Service Center (hereinafter referred to as "Sponsor") and the Governing Authority of the Midnimo Cross Cultural Academy (hereinafter referred to as "School"), and hereby amends and supplements their Successor Community School Sponsorship Contract in effect from July 1, 2018 to June 30, 2023 (hereinafter referred to as "Contract"). The Sponsor and the School shall be hereinafter collectively referred to as "the Parties."

WHEREAS, pursuant to Section 9.7 of the Contract, the term of the Contract is for a period of five (5) years, commencing on July 1, 2018 and ending on June 30, 2023 (hereinafter referred to as "Term"); and

WHEREAS, due to the COVID-19 pandemic, Ohio Governor, Mike DeWine's school closure mandates during the 2019-2020 school year and disruptions to school scheduling during the 2020-2021 school year, the state's education community has experienced unprecedented changes. This has resulted in the availability of data released from the Ohio Department of Education. Therefore, the Parties desire that the Term of the Contract be extended an additional one (1) year, until June 30, 2024; and

WHEREAS, as required by R.C. 3314.03(E), the Sponsor finds that the School's compliance with the applicable laws and the terms of the Contract, and the School's progress in meeting the academic goals prescribed in the Contract, have been satisfactory.

NOW, THEREFORE, for mutually acceptable consideration, the Parties hereby agree as follows:

1. The Term of the Contract shall be extended an additional one (1) year and thus shall be for a period of six (6) years, commencing on July 1, 2018 and ending on June 30, 2024.
2. All of the terms and conditions set forth in this Addendum shall take effect immediately.
3. All of the terms and conditions set forth in the Contract, except for those amended pursuant to this Addendum, shall remain in full force and effect.
