# NWEA Analysis from Bruce Hansel with Informed Improvement:

Atlas Elementary has achieved exceptionally strong levels of student achievement and growth in its first year of operation.

Kindergarten students were first assessed with the NWEA nationally normed test this winter. Their average achievement level was better than 68% of test takers in both reading and math. First grade students had exceptionally strong growth with above average growth between the fall and winter NWEA tests of approximately seven weeks in reading and ten weeks in math. This growth corresponds to school and teacher effectiveness better than 80 to 90 percent of schools per research-based effectiveness models.

# **Executive Director Report**

Executive Director: Colby Heckendorn

- Current Enrollment: Unchanged at 118 KG & 1st Graders

- Intent to Return
  - 100% of families have completed the Intent to Return Form; due to the significant work of the Atlas team and the strong relationships that the team has built with families.
  - 4 out of 118 or 3.3% of students have indicated they will not be returning to Atlas
    - Student 1: Moved to the county; kept house in city so they could finish the school year
    - Student 2: Switching to a charter school in the city that is closer to their home
    - Student 3: Participating in VIC and attending school where older siblings attend
    - Student 4: Switching to a charter school in the city that is closer to their home
- Student Recruitment Dashboard
  - 65 Total Applications Submitted
  - 40 families have completed registration
    - 50 Kindergarten applications for 75 Seats
    - 8 First Grade applications for 6 projected seats
    - 7 Second Grade applications for 7 projected seats
  - Not yet on a waitlist because we will over enroll (at a rate acceptable to our sponsor)
- Staffing Update; Atlas model is that assistant teachers role is a pipeline to a lead teacher position.
  Atlas pays assistant teachers significantly more than assistant teachers in leading districts.
  Assistant teachers are compensated more if they are in a certification program, and we have now created six certified teachers.
- Atlas has received 82 applicants for open positions for 2022-2023 this is roughly 6 per position.
- Review and Discuss <u>Test Integrity and Security Policy</u> (reviewed by Michelle Bosse). The MAP test is required by DESE, but doesn't start until third grade.
