NOW THEREFORE, the parties modify the Contract as follows:


1. Attachment 6.3 shall be replaced in its entirety with the attached.

**WHEREAS**, pursuant to Section 6.1 of its sponsorship agreement with its Sponsor the School is authorized to enroll students in grades kindergarten through twelve, but currently serves students in grades 6-8;

**WHEREAS**, the School wishes to serve students in grade 9 in the 2022-23 school year;

**WHEREAS**, the School notified the Sponsor and received its consent to add this additional grade,


**NOW THEREFORE**, at a duly called and noticed public meeting, the Governing Authority of the School adopted the following resolutions:

**RESOLVED**, to approve the enrollment of students in grades 6-9;


**RESOLVED**, to authorize Dr. Estella Stephens or her designee to review the existing Policy 241.5 - Enrollment and Residency Policy and amend as needed to ensure that it conforms with the School's intention to allow for the enrollment of students grades inclusive of grades 6-9; and

**RESOLVED**, to authorize Dr. Estella Stephens to take all steps necessary and proper on behalf of the School to effectuate this action, including but not limited to the execution of an amendment of the sponsor contract, and the review and revision of the School's education plan and financial plan to ensure it reflects the School's enrollment.


