Terminology

- KCPES = KC Public Education System (district and charter).
- Local Education Agencies (LEAs) = an entire district or charter (21 total in KCPES).
- Missouri Assessment Program (MAP) = the assessments students take to determine grade-level status of a student in grades 3-8.
- End of Course (EOC) Exams = high school assessments students take as part of Missouri's course programs.
- Status = how a student/school/LEA scored on an assessment (level), regardless of where they scored previously.
- Growth or Improvement = the degree to which a student/school/LEA improved from one year to the next, regardless of their level.

Summary of Findings: Enrollment

- 1. KCPES enrollment is up 1% in the 2022-23 SY (~300 students).
- 2. PK: Enrollment is relative unchanged from 2021-22 (1,134 students) to 2022-23 (1,135 students). There were 1,296 PK students in 2018.
- 3. K-3: Enrollment is slightly up from 2021-22 (8,916) to 2022-23 (8,984). There were 9,651 K-3 students in 2018.
- 4. Charter and KCPS enrollment remain close to 50/50.
- 5. Demographically, at the charter and KCPS level, our systems are very comparable, though KCPS has a higher percent of students with disabilities.










Kansas City Today (Enrollment)












Kansas City Today (Demographics)





In KCPES, 10% of students are students with disabilities (9% in charter schools, 12% in KCPS) and 21% of students are students who are Limited English Proficient (LEP) (20% in charter schools and 22% in KCPS).

Between KCPS and charter schools, the percentage of students who are black and LatinX are nearly identical.

Context

- 2022 academic data represents our second year of data post-COVID.
- The 2021 academic data gave a glimpse, however, debate was had regarding the data because schools and LEAs were not accountable for test scores in 2021, as the goal was to ensure students tested for informational purposes but not to penalize due COVID.
- The stage is with the inclusion of NAEP the National Assessment of Educational Progress which students take, in a representative sample, around the country.










Long-term Trends: NAEP (G4 Reading)

Missouri's performance on NAEP remained largely steady (or modestly increased) from 2007 to 2017, and has declined since. This decline has been at a pace more quick than the rest of the country, with Missouri losing ground to other states.






Long-term Trends: NAEP (G4 Math)

Missouri's Black/white performance gap in 4th grade Math has remained **essentially unchanged since 2007**. Missouri's Black/white performance gap oscillates between the mid-teens and mid-twenties in national comparison.






2022 STATE PERFORMANCE: ELA

% Proficient and Advanced (ELA)














2022 STATE PERFORMANCE: MATH








2022 STATE: RACE/ETHNICITY

Proficient + Advanced (race/ethnicity) for All Subjects (including science)












2022 STATE: BY INCOME



A Call to Action

- For students who are black: there is not one school district/charter school in the state where the percentage of kids proficient/advanced is over 50% in any subject. The statewide average for all subjects is 17%.
- For students who are LatinX: there are 17 school districts/charter schools in the state where the percentage of kids proficient/advanced is over 50% in any subject. The statewide average for all subjects is 31%.
- For students who are low income: there are 4 school districts/charter schools in the state where the percentage of kids proficient/advanced is over 50% in any subject. The statewide average for all subjects is 41%.

Summary of Findings: Performance

Celebrations, Hope, and Urgency

- 1. Students in KCPES had a "bounce back" from 2021 to 2022, after a steep COVID loss. Students "gained back" about 50% of the decline from 2019 to 2021 in 2021 to 2022.
- 2. Across race/ethnicity, the "bounce back" holds in a similar manner, with all racial/ethnic groups seeing similar rates of improvement.
- 3. Relative to surrounding districts and counties, KCPES improved more.
- 4. Concerningly, the data suggests that our youngest learners are still declining or not improving, suggesting that the impact of COVID on students PK-3 is lingering.










KCPES Performance (All Grades)












KC Metro Performance












Math Performance












Performance: KCPES Race/Ethnicity







3rd Grade Reading Proficiency

- There are 2,174 students in grade 3 in KCPES who tested
- ▶20% of KCPES students are proficient or advanced in reading in grade 3
 - Statewide this rate is 41%
 - 14% proficiency for students who are black
 - 20% proficiency for students who are LatinX

➤ Of the 2,174:

- 427 were proficient or advanced in reading (compared to just under 400 in 2021)
- o 165 of the 427 are black
- 98 of the 427 are Hispanic/LatinX
- > Of the 2,174: 1,189 scored below basic (over 50%)
 - Below basic is equivalent to at least 1 or more grade levels behind.








An Example: City Investment in High-Dose Tutoring

"In a review of the pre-pandemic research, tutoring has been found to generate a gain of about .38 standard deviations. Well, you could provide a tutor to every single student in a high-poverty school that was remote for half the year and *still* not close the gap. You could get close, but you wouldn't close that gap. You we know that districts are never going to be able to hire enough tutors to provide one to every student in a high-poverty school, let alone deliver that tutoring at the level of quality as these program evaluated in the research.

We can't be thinking of this as a one-year catch-up. If we are really committed to making students whole and eliminating these losses, it's going to be multiple years."



Charter Impact

- 1. Genesis charter has been notified that their charter is being revoked due to persistently poor performance and growth. Final decision is mid-February.
- 2. Hogan Prep has been placed on probation for "poor academic performance" and the sponsor has suggested the school close one or more campus, work with another charter, or relinquish their charter.
- 3. DeLaSalle, KIPP, Lee A. Tolbert have been provided a letter of concern regarding their academics and informed of specific actions they should take to address those concerns.









KCPS Updates

- 1. School Closures: KCPS has approved (Jan. 2023) the closure of two schools Longfellow and Troost after debating closing up to 10 schools.
- 2. Superintendent Search: KCPS opened application Jan. 31. Interviews to occur in February, finalists identified by end of Feb.
- 3. KCPS board elections: election is April 4, 2023 and June 20, 2023 (for third district only).
 - 2nd district (Nate Hogan): Candidate Jamekia Kendrix
 - At-large (Jennifer Wolfsie): Candidate Josh Jackaway
 - 4th district (Marvia Jones): write-in
 - 3rd district (Manny Abarca): TBD (filing deadline of March 14)
