

Modification No. 1

To Amended and Restated Ohio Community School Contract

BY and BETWEEN the Board of Education of the Cleveland Municipal School District

and

NEAR WEST INTERGENERATIONAL SCHOOL

WHEREAS, the Cleveland Municipal School District (CMSD) and the Governing Authority previously entered into a Community School Contract (“Contract”) effective from July 1, 2019 through June 30, 2024; and

WHEREAS, CMSD and the Governing Authority in 2020 executed a modified Sponsorship Contract for a Community School, covering the same time period, also referred to as the “Amended and Restated Ohio Community School Contract”; and

WHEREAS, CMSD and the Governing Authority agree to the following additional modifications;

NOW THEREFORE, the parties modify the Amended and Restated Ohio Community School Contract as follows:

Effective July 1, 2020

Replace paragraph 30 with the following:

30. EDUCATIONAL PLAN. The educational program of the School, including its mission, the characteristics, ages, and grades of the students it is expected to attract, the focus of the curriculum, and a description of how it will fulfill its civic function of helping to prepare students to be informed and engaged citizens, is attached as **ATTACHMENT 3** and incorporated by reference. The School is not planning to seek designation as a STEM school equivalent under ORC Section 3326.032.

In accordance with ORC Section 3314.03(A)(11)(j), if the School operates a preschool program that is licensed by ODE under ORC Sections 3301.50 through 3301.59, the School shall comply with those Sections and with the minimum standards for preschool programs prescribed by rules adopted by the State Board under ORC Section 3301.53.

The school may implement a remote learning plan that has been submitted to the Ohio Department of Education in accordance with Section 16 of Sub. H.B. 164 of the 133rd General Assembly.


The School’s mission, the ages and grades of its students, its focus, and the characteristics of students the School is expected to attract shall not be materially changed, nor shall the School seek designation as a STEM school equivalent under ORC Section 3326.032, without prior written notice to Sponsor and a 30-day opportunity for the Sponsor to comment or object. All other categories may be modified without prior notice to the Sponsor in the ordinary course of business. Modifications under this Section shall take effect on July 1 unless otherwise agreed to by the Parties.

ALL OTHER SECTIONS, SUBSECTIONS, TERMS, OR PROVISIONS OF THE CONTRACT, AS THE SAME HAVE BEEN AMENDED, SHALL REMAIN IN FULL FORCE AND IN EFFECT UNLESS OTHERWISE SPECIFICALLY MODIFIED HEREIN.

CONSUMER DISCLOSURE

From time to time, LakeShore School (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign, Inc. (DocuSign) electronic signing system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after signing session and, if you elect to create a DocuSign signer account, you may access them for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. Withdrawing your consent
