Open Enrollment

Admission Procedures:

Any eligible student who resides in the Kansas City, Missouri School District attendance area can complete the application process at Scuola Vita Nuova Charter School. Preference will be given to siblings and students residing in a two mile radius of Scuola Vita Nuova.

Enrollment Procedure:

Scuola Vita Nuova will maintain an open enrollment period for the upcoming school year from January 1– March 1, 2022. Applications must be received by March 1st at 4:00 P.M. Scuola Vita Nuova will exercise a lottery system to determine enrollment. Applications can be downloaded from the SVN website (www.svncharter.org) or picked up in the SVN office.

Entrance Age for Kindergarten:

Students must be five(5) years old before September 1st preceding

entrance.



School Wide Academic Goals

- Goal 1: 3rd – 8th Grade ELA Proficiency will increase from 31.7% - 41%
- Goal 2: 3rd – 8th Grade ELA Proficiency will increase from 32.4% - 42%
- Goal 3: 5th & 8th Grade ELA Proficiency will increase from 32.1% - 42%
- Goal 4: K-2nd students reading at or above grade level, as measured by F&P Reading Benchmarks, will increase by 10%.
- Goal 5: SVN students will achieve more than a year's growth for each year of instruction in Reading (STAR).
- Goal 6: SVN students will achieve more than a year's growth for each year of instruction in Mathematics (STAR).



MSIP/APR

The Missouri School Improvement Program (MSIP) Annual Performance Report (APR) provides local education agency (LEA) and building-level data for stakeholders and serves as the primary basis for the classification of school districts. In accordance with Section 161.855.4, RSMo, the first year under MSIP 6 is considered a pilot year; therefore, the 2022 APR may not be used to lower a district's classification. The APR is also used by charter sponsors to inform renewal decisions.

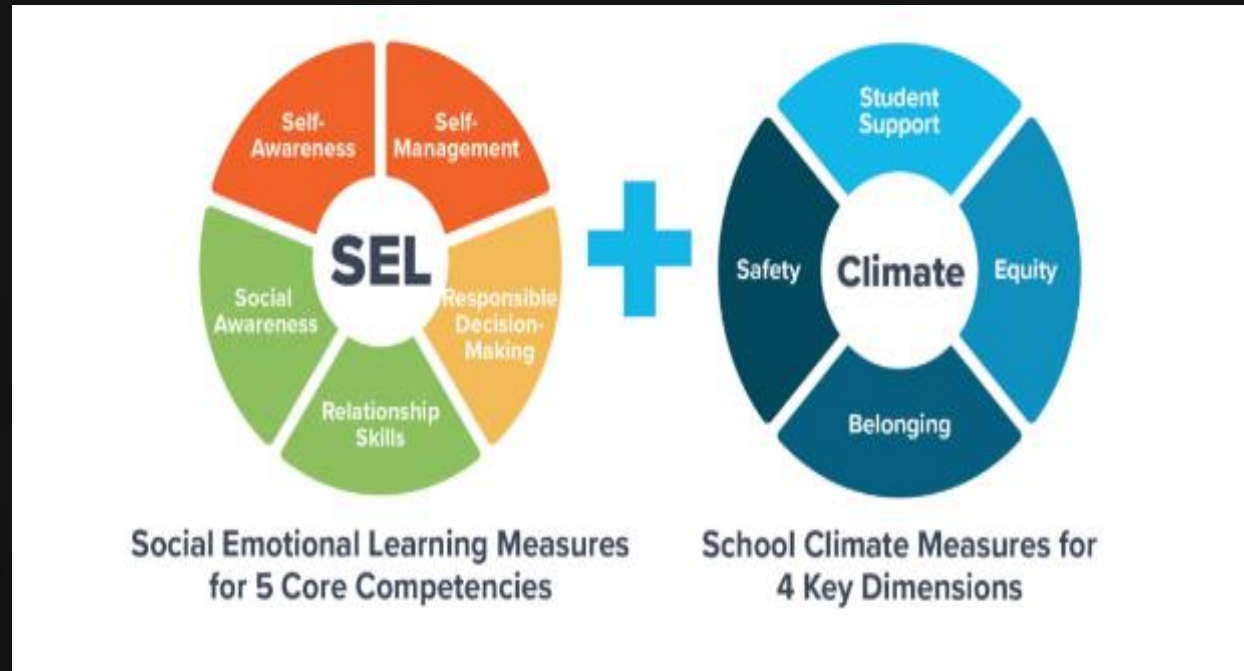



School Safety

“All school personnel play an important role in school safety. Training on safety matters helps prepare them to respond to incidents of school violence. The school personnel best positioned to respond to acts of violence are those with specialized training such as school resource officers (SRO), who are typically sworn law enforcement officers, and school safety officers (SSO), who are typically unsworn school security staff. These officers have been specifically trained in school safety to act as a first-line of defense. Their presence at school facilities and on campus allows them to build the kinds of relationships with students that can prevent or mitigate incidents of school violence.”



“Fostering a culture of connectedness is another important aspect of school safety.”



School Safety

“Schools can reduce the likelihood of a violent incident with significant casualties from occurring on their campuses by establishing a strong security team, completing a security assessment, and developing and implementing appropriate plans for security and emergency operations.”
