
#### **♦2022-2023 ENROLLMENT♦**

SVN is accepting applications for the current 2022-2023 school year. For your application to be complete you must include:

- Completed Lottery Application Form
- Proof of Address (current utility bill gas, electric, water)
- Birth Certificate









Families will be contacted if there is an opening in the child's grade level. Openings will continue to be filled throughout the school year. In grade levels with no openings, applicants will be placed on a waitlist for the remainder of the school year. Please note that applications are received throughout the school year and are added to the established wait list in accordance with the priority they receive. This could affect the number your child has on the waitlist.

SVN will begin accepting applications for enrollment for the 23-24 school year on January 1, 2023.

For your application to be complete and included in the lottery, you must include:

- Completed Lottery Application Form
- Proof of Address (current utility bill gas, electric, water)
- Birth Certificate

### In addition:

- Your child must turn 5 years old before September 1, 2023 to apply to Kindergarten.
- You must live within the Kansas City Missouri School District boundaries to apply to Scuola Vita Nuova Charter School.

Admission is determined by a random lottery with no student identifiers. In order to be considered for the lottery, applications must be submitted by March 1st at 4:00 PM. Lottery preference is given to the following:

- Siblings of currently enrolled and newly accepted children
- Children living within a 2 mile radius of Scuola Vita Nuova Charter school

If your child is selected in the lottery, additional enrollment information will be requested and required prior to admission.



Important Dates for the 2023-2024 application season:

- Application Window Opens: January 1, 2023
- Application Deadline for Lottery: 4:00 PM March 1, 2023
- Lottery: March 2, 2023
- Offers Sent to Families: March 3, 2023

Applications will continue to be accepted after the enrollment lottery has taken place. Openings will continue to be filled throughout the school year. In grade levels with no openings, applicants will be placed on a waitlist.
